SECOND ORDER AMENDING JANUARY 28, 2015 FINAL ORDER

The District of Columbia Board of Medicine (the Board) issued a Final Order on January 28, 2015 (the Final Order), indefinitely suspending Respondent, Mubashar Choudry, M.D.'s, license, and placing him on probation for five years with conditions enumerated in the Final Order.

On October 28, 2015, the Board amended the Final Order to permit Respondent to participate in only one alcohol monitoring program, specifically the Maryland State Board of Physicians Physician Rehabilitation Program (MSBOP PRP), rather than both the MSBOP PRP and the Medical Society of the District of Columbia Physician Health Program (MSDC PHP), so that Respondent would not duplicate treatment efforts unnecessarily. Accordingly, the Board struck the requirement that Respondent participate in the MSDC PHP and required Respondent's continued successful participation in the MSBOP PRP to satisfy the probationary terms of the Final Order.

Respondent subsequently submitted a petition to terminate the suspension imposed in the Final Order. On December 30, 2015, Respondent appeared with counsel before the Board to

support his petition to terminate the indefinite suspension. The Board considered Respondent's oral presentation and his written submission to terminate the indefinite suspension imposed under the Final Order. In consideration of all the reasons Respondent set forth in support of his request to terminate the indefinite suspension of his District of Columbia license to practice medicine, and the entire record before the Board, the Board grants Respondent's request. The Board's intent herein is to permit Respondent to re-engage in the active practice of medicine in the District of Columbia, provided, however, that he remain under all of the probationary terms of the Final Order.

The terms of the Final Order in all other respects remain in effect and are incorporated herein by reference as though they have been fully set forth.

ORDER

UPON CONSIDERATION of the Respondent's request to terminate the indefinite suspension imposed under the Final Order, and the entire record herein, it is by the District of Columbia Board of Medicine hereby:

ORDERED, that Respondent Mubashar Choudry, M.D.'s REQUEST TO TERMINATE THE INDEFINITE SUSPENSION imposed under the Final Order is GRANTED; and it is further

ORDERED, that the INDEFINITE SUSPENSION of Respondent's license to practice medicine in the District of Columbia is hereby TERMINATED; and it is further

ORDERED, that ALL TERMS of the January 28, 2015 Final Order are hereby incorporated by reference as though they have been fully set forth, and shall remain

EFFECTIVE, except as amended in the Order Amending Final Order of January 28, 2015, and as further amended herein; and it is further

ORDERED, that Respondent shall comply with all of the conditions of the January 28, 2015 Final Order; and it is further

ORDERED, that to the extent there is any conflict between this Amended Order and the January 28, 2015 Final Order, the January 28, 2015 Final Order shall control; and it is further

ORDERED, that Respondent shall comply with all of the conditions of the Maryland State Board of Physicians' Order Following Show Cause Hearing, dated November 25, 2013; and it is further

ORDERED, that any violation of the Maryland State Board of Physicians' Order Following Show Cause Hearing, dated November 25, 2013, shall constitute a violation of this Order; and it is further

ORDERED, that Respondent shall comply with the District of Columbia Health Occupations Revision Act, as amended, and all laws, statutes, and regulations governing the practice of medicine in the District of Columbia; and it is further


ORDERED, that in the event Respondent violates any term or condition of probation or this Order, the Board, after notice and an opportunity to be heard, may impose any sanction which the Board is authorized to impose under D.C. Official Code § 3-1205.14, including a reprimand, additional terms and conditions of probation, the suspension or revocation of Respondent's license, as well as impose a civil penalty as permitted by the laws of the District of Columbia; and it is further

ORDERED, that this is a public document.
