FINAL DECISION AND ORDER OF THE BOARD

This matter comes before the District of Columbia Board of Medicine (Board) following Dr. Paul G. Prunier, M.D.'s (Respondent) submission of an affidavit, pursuant to D.C. Official Code § 3-1205.17, voluntarily surrendering his license to practice medicine in the District of Columbia.

On or about May 24, 2016, Respondent surrendered his license to practice medicine in Maryland, and, on May 31, 2016, the Maryland Board of Physicians accepted Respondent's surrender of his license to practice medicine in that state. The D.C. Department of Health (Department) initiated proceedings to summarily suspend Respondent's license to practice medicine in the District of Columbia, pursuant to D.C. Official Code 3-1205.15(a), based on the Maryland Board of Physicians' suspending Licensee's Maryland license to practice medicine in Maryland.

When contacted regarding the impending summary suspension, Respondent elected, instead, to surrender his District of Columbia medical license. Accordingly, on July 29, 2016, Respondent executed an affidavit of surrender, pursuant to D.C. Official Code § 3-1205.17. The affidavit of surrender is attached to this Order.

The Board accepts the surrender of the license and the Board has determined to revoke Respondent's license to practice medicine, pursuant to D.C. Official Code § 3-1205.17(b).

ORDER


ACCORDINGLY, UPON CONSIDERATION of the foregoing, it is by the District of Columbia Board of Medicine,

ORDERED, that Paul G. Prunier, M.D.'s, License No. MD12173, BE and is hereby REVOKED, pursuant to D.C. Official Code § 3-1205.17(b); and it is further

ORDERED, that the foregoing is a FINAL ORDER of the District of Columbia Board of Medicine.



AFFIDAVIT OF PAUL G. PRUNIER, M.D.


I, PAUL G. PRUNIER, M.D., am over the age of eighteen, and I am competent to state the following:
